The addition of attapulgite as a thermally activated mineral product that is suitable for a wide range of filtration and sorbent applications. This mineral provides greater sorption capacity and a high level of particle resistance, resulting in less wastage. BountiGel Blend is a non-toxic soil conditioner/humectant that rapidly absorb and maintain water, increases the cation exchange capacity in the soil solution which keeps the water accessible to seeds and plants at their root zone.
